Process of Drafting of New Bylaws

- Bylaws proposal represents months of research, prayer, consultations, member input and team discussions
 - October 2018 → 13-member Governance Team spent hundreds of hours in Bible research and studying models of church governance
 - Input was invited from members, elders, pastors and staff
 - Comments and questions were addressed throughout the process through personal interactions, email responses and All Church Q&A sessions
 - An estimated 150+ members had direct input to the bylaws

Bylaw Draft Timeline

- Oct/Nov Governance Team formed
- Feb 24 Governance/Bylaws Team provided the first bylaws draft to the members at All Church Meeting (hard copy and web version)
- Mar 3 & 10 Governance/Bylaws Team had meetings for members to discuss the bylaws and provide input
- May 19 Second bylaws draft proposal given to members (Church website and paper copies at All Church meeting)
- Jun 4 Final bylaws "proposal for vote" sent via letter to members and posted on Church website

Your Voices were Heard and Considered

- All inputs were prayerfully considered along with legal constraints and guidance
- We committed to always:
 - Remain true to the Scriptures
 - Compromise, if necessary, on other issues for the good of the Church, i.e., have "Dora" attitudes

We acknowledge that this is not a "perfect" document but we believe that it is God-directed and it is a good way ahead for Hoffmantown. It can, and will be, changed in the future by Hoffmantown members as circumstances change or as wise men and women are led by God to change it.


